We hope that everyone is having an enjoyable school year!

On behalf of the PTO, we would like to thank everyone for a very festive and successful Mystery Dinner in November. The event was well attended with 166 participants and we raised \$8,000 for the school. We are extremely grateful for your support and truly feel fortunate to have such an engaged community.

The PTO is operated and funded solely through the support of current Peirce Families. The annual PTO budget is approximately \$57,000, which goes directly to support the following areas:

**TECHNOLOGY:** New ipads and carts; laptops; docking stations; LED projectors; external hard drives; speakers and headphones.

**EDUCATIONAL ENRICHMENT:** Creative Arts & Sciences programs in every grade; new books and e-books to update the library; CAPP and Understanding our Differences programs; Parent/Principal Coffees.

**SCHOOL SUPPORT:** Teacher and principal discretionary funds; school directory; school supplies program; merchandise; teacher appreciation events.

**COMMUNITY BUILDING:** Social events organized for students, parents and faculty including Back to School Picnic, Mom's and Dad's Nights Out, Family Movie Night, Family Dance.

**CAPITAL IMPROVEMENTS:** Maintaining school grounds and gardening; Newton Serves

Annual fundraising this year will be comprised of only one contributing event: the Annual Appeal. We are fortunate to also raise additional funds through community building events such as the Mystery Dinner, merchandise sales and the Book Fair to supplement our budget needs. This year, in order to simplify the process and consolidate the fundraising timeframe into one period, we have decided to focus efforts primarily on the Annual Appeal. Our goal is to raise \$20,000 through the Appeal with as much community participation as possible. This goal will enable the PTO to sufficiently operate and fund the areas outlined above for the next year while allowing us to save money for potential future projects around technology and capital improvements.

Our Appeal will begin around mid-March and our goal is to raise \$20,000 by mid-May. **We are asking for support and participation from all families in the Peirce community. No amount is too small and all contributions make a difference as we work together to support our children's education.** Every child at Peirce benefits from the money raised.
